1) Aim of the Competition

The Warrior @ 80 Documentary / Short Film Competition is being organised to bring today's young generation more closer to the socio-political career of Hon. Shri. Sharadchandraji Pawar Saheb, and to encourage the young film makers to showcase their talent and skills to produce quality films reflecting career of Hon Pawar Saheb. This competition also aims to create a significant platform for young talent from Maharashtra to showcase their talent to the world

2) Awards & Prizes

1) Best Short Film

Trophy, Certificate plus cash prize of Rs. 1,00,000/- to the director of the film

2) 2nd Prize

Trophy, Certificate plus cash prize of Rs. 75,000/- to the director of the film

3) 3rd Prize

Trophy, Certificate plus cash prize of Rs. 50,000/- to the director of the film

4) More Prizes!

A . Special Prizes (Total 12)

The jury will award Special Prize to one film from each of 6 regions of Maharashtra i.e. Vidarbha, Marathwada, Konkan, North Maharashtra, Western Maharashtra and Mumbai (MMRDA) region, plus women directors from each of these 6 regions will also receive Special Prize. These special prizes include certificates plus cash prizes of Rs. 10,000/- to each director.

B . Special Prizes (Total 2)

The jury will also award one Special prize to filmmakers from outside the Maharashtra and one Special Prize for LGBTQ+ filmmaker. These special prizes include certificates plus cash prizes of Rs. 10,000/- to each director.

C . Audience Choice Award (Total 3)

Top 3 films which get maximum likes on Supriya Sule's YouTube channel will receive Audience Choice Awards Audience Choice Awards include certificates plus cash prizes of Rs. 10,000/- to each director.

D . The winners of all these awards will be announced on 12th December 2020, the 80th birthday of Hon. Sharadchandraji Pawar Saheb. We will have special screenings of all these award winning short films along with prize distribution on a later date in presence of eminent personalities.

(Reference : Important decisions involving Dr. Babasaheb Ambedkar Marathwada University and many other in connection with social justice in Maharashtra.)

3) Hon. Sharad Pawar Saheb's contribution in national-international agriculture field

4) Hon. Sharad Pawar Saheb's contribution in industrial development in Maharashtra

5) Art-Literature-Culture: Respected & Loved by Hon. Sharad Pawar Saheb

6) Hon. Sharad Pawar Saheb: Strong Supporter of Sports

7) Hon. Sharad Pawar Saheb: A Saviour In Times of Emergency

4) Eligibility

1) Competition accepts Documentary /short films of maximum duration of 3 minutes, including film's opening and closing credits.

2) The Documentary /short film must showcase / highlight any one of subject mentioned above in clause 3 and it should be mentioned at the beginning of the film.

3) Film makers should send email to rwshortfilm@gmail.com with Google Drive link of their films (with download option). Entry Forms and Regulations are available for download at www.supriyassule.com and www.ncp.org.in.

A) The Google Drive link of film will be considered for film submission. This link must have download option.

B) VDO file should be in .MP4 or .MOV format, HD quality (720p or 1080p), size not more than 500 Mb, 5.1 or 2.0 channel audio embedded, Stereo or Mono sound. Films shot on mobile phones will be accepted.

C) The email of film link must also accompany entry form, rules & regulations (page nos. 4, 5, 6 only). Film makers / applicant must print these pages, fill them up with correct information, sign it and scan it in .PDF format to send along with film link.

- 4) Film submissions will open on 12th November 2020 and close on 05th December 2020.
- 5) Films made in any language or without dialogues are accepted.
- 6) No age restriction for the film maker.
- 7) All submitted films will go through a primary selection process, and selected films will be uploaded on Supriya Sule's YouTube channel (www.youtube.com/c/supriyasulencp) for general public viewing.
- 8) Each selected film will be reviewed by an esteemed jury. Each film's jury ratings and YouTube likes will be considered for the results. Only likes received by each film will be considered, not the views.
- 9) Organisers will not be responsible if YouTube blocks / bans any film for copyright issue. In that case, the film entry will still be eligible for competition.

5) Film Submission procedure

- A) Only the entries made via email to rwtshortfilm@gmail.com will be considered for competition. Entry submitted on USB drive or any other medium will not be considered.
- B) All the selected short films will be uploaded on official Supriya Sule YouTube channel (www.youtube.com/c/supriyasulencp) for public viewing starting from 20th November 2020.
- C) Any film with technical problem in its VDO file or email submission will be disqualified.
- D) One filmmaker can submit more than one film as a director or producer.
